- Health

However gradually it started growing and took up its initiative in working in more areas like:

- Women Empowerment
- Natural Resource Management
- Education
- Health & Nutrition
- Self Governance System
- Lobby and Advocacy

In the year 1990 it got associated with likeminded people and organisation. This organization was registered in the year 1992. It gets support from various agencies both from within and outside the State which has helped it to march ahead. At present WORD is working in Keonjhar District. WORD is not only working within the periphery of Keonjhar but it has widely spread its horizon beyond the district.

The head office of WORD is located at Khajuria of Akul of Keonjhar district. The branch/liaison office is located at Biswanathpur of Banarapal Angul district. WORD has five field offices which are located in five different places: which are Mining Road New Colony, Banspal and Joda of Keonjhar and in Deogarh at Dudhianali and proper Deogarh town.

Women Empowerment:

Empowerment is a process that challenges our assumptions about the way things are and can be. It challenges our basic assumptions about power, helping, achieving, and succeeding. The empowerment of women occur in reality, when women achieve increased control and participation in decision making that leads to their better access to resources, and therefore,



improved socio-economic status. At the operational level, empowering process entails those ideas/actions which enable women to understand their situation. It enables them to exercise their rights for a just share in the power and resources at all level. It enhances women to participate in the decision making process which brings about changes in their living conditions.

WORD has put in its efforts to empower rural women by taking up different plans and projects. It has been organizing various kinds of orientation, training and awareness programmes in order to develop a sense of awareness among them.



STANDS WITH OWN DIGNITY

Lili Nayak daughter of Dambarudhar Nayak of Bimala village of Bimala GP under Telkoi Block of Keonjhar District is a distress woman married to Mr. Amulya Sing son of Bhimsen Sing of Sundarmundi village of Dhenkanal District seven years back. After marriage the couple was maintained happy life. Afterwards her husband with his family tortured her for dowry and her infertility. For unbearable torture she came back to her parent's home in the year 2008. During the period she did not have any family support to fight for her rights. So she lived in

very miserable condition in this village.

WORD the women led social development voluntary organisation has associated with community to develop the socio, economic and cultural condition of the rural poor women in the project area. The organisation gave different training inputs, exposure to women SHGs leaders. The SHG members of the village have done different development activities in the village. The SHG member s as well as Lili Nayak requested to WORD for the economic development of the distress woman.

WORD realized the situation and supported to Lili Nayak worth Rs. 2750/- in the 1st week of February 2010 and she started a grocery business in her village with great interest. Now the grocery shop is well in functioning and monthly she is getting Rs.500/- net profit per month. She is happy in her business and shared to others "I got a new hope for live and want to stand in her own dignity

activities have made to sustaining livelihoods. The two key components of the SLA are:

- a *framework* that helps in understanding the complexities of poverty
- a set of *principles* to guide action to address and overcome poverty

EDUCATION



Education is what makes us into good human beings, honest, loyal citizens and, above all, makes us fit for a livelihood. Vocational educational in India aims to develop skilled manpower through diversified courses to meet the requirements of mainly the unorganised sector and to instill self employment skills in people through a large

number of self employment oriented courses. WORD is working on Shiksha Chetana since

August 2008 with the support of Development Focus and Educan Foundation and NCLP since the year 2008 with the support of Project Officer cum District Labour Officer . With the support of the above two programmes it has started National Child Labour School, Residential Bridge Course Schools (NRBCS) and Tailoring Unit, Tamarind Processing Unit, Bee-Keeping Unit in the schools and also it promotes goat rearing.

Different Activities and Achievements:

- ✓ A National Child Labour School is functioning in Golagadia village of Telkoi block of Keonjhar district. A total of 50 learners have learned in that school. A total number of 50 learners are learned in NCLP school
- ✓ Two Residential Bridge Course Schools are functioning 2 gram panchyats of Telkoi block of Keonjhar district. A total number of 41 learners are learned in 2 NRBC Schools
- ✓ One Children Festival was organized in the month of January in 2010 year and a total number of 198 school children participated in it
- ✓ Two Tailoring Units are functioning for life skill education in two different villages
- ✓ 39 number of children initiated the Bee-Keeping Unit in two schools
- ✓ Twenty children of five School introduced five Tamarind Processing Unit and produced Tamarind produces and got a sum of worth Rs. 800/- as net profit
- ✓ 30 drop out girl children of six villages in two gram panchayats initiated the practice of Goat rearing
- ✓ Two variety of local based products were demonstrated by 20 school children
- ✓ 5 ethnic groups developed their best practice at Community level

Forest (Forest Based Livelihood Programme and OFSDP):

A forest is a biotic community which is predominantly composed of trees, shrubs or any other woody vegetation and is usually a closed canopy. Forests are a vital livelihood support system for mankind and especially for the rural people who heavily rely on forest. It provides with valuable items like NTFP Products, timber, fuel wood, medicines etc.



With the partnership of CPF, Secunderabad and Forest department the following results were done.

- 52 nos. of VSS formed and strengthen in 52 villages of 5 Ranges like Telkoi, BJP, Sadar, Ghatagoan and Champua under Keonjhar Forest Division
- 13 nos. of CFM formed in 13 villages of 5 Ranges
- 2879 land patta issued to land titles holder under FRA 2006 of 5 Ranges of Keonjhar Forest Division
- 18108 Mandays created in 9 GPs under NREGA
- 35 nos. of Micro Plan developed in 35 villages of 5 Ranges
- Forest regenerated in 6 villages of 3 GPs and 120 Hectors land covered with 36000 plants



FRA

In FRA it is seen that the total Land Patta Issued to the Land Holders is 2879 in number. Out of the total number in Sadar region 232 number of Land Patta was issued, whereas in BJP region it was 1199. It was recorded that 722 numbers was issued at Telkoi and 370 at Ghatoan. In Champua it was 356.

NREGS Facilitation

In Keonjhar division it was seen that in a total number of 9 GPs 8240 Job cards were available and 18108 Man days was created.

HEALTH



Maternal health refers to the health of women during pregnancy, childbirth and the postpartum period. While motherhood is often a positive and fulfilling experience, for too many women it is associated with suffering, ill-health and even death. Children represent the future, and ensuring their healthy growth and development ought to be a prime concern of all societies. Newborns are particularly vulnerable and children are vulnerable to malnutrition and

infectious diseases, many of which can be effectively prevented or treated. WORD works in the health sector particularly on issues related to maternal and child health. It also works with people affected with HIV/AIDS and generates awareness on health and nutrition among the elected PRIS and the general people. It also works among the Anganwadi workers. WORD is of the view that in order to improve maternal and newborn health by reducing mortality and morbidity related to pregnancy and child birth, it is ess ential to build *continuum of care* that increases access to and use of skilled care during pregnancy, birth and the post partum period. WORD in association with District Health Administration and Care-India is working at Banspal, Telkoi Block so as to impr ove the Nutrition and Health service to be easily accessible by communities. With the support from OSACS, WORD is working at Joda Block to reduce high risk behaviour.

Major Activities & Achievements on Health Sector:

- Workshops on HIV/AIDs were organized at the Gram Panchayat level and a total number of 274 persons were taken each for both a one to group meeting and one to one interaction. Group meetings were done with 7033 person on HIV/AIDS
- ✓ 71500 condoms were distributed for safe sex practice
- ✓ Street plays/Pala were performed in the central place of 24 Hattings related to issues on health and nutrition and HIV/ AIDS
- ✓ A total number of 42 Sashu Bohu Pati Samilan were organized and 2156 targeted beneficiaries were sensitized and discussed one -to one and one to group mode on best behavioural aspects with thematic module plan of quality ANC, NBC and ACF practice
- ✓ PRIS have been provided series of Orientations in two Blocks to have conceptual clarity and understanding the key critical Health and Nutrition issues and lacunas in order to jointly plan for quality improvement.
- ✓ Gram Panchayat took decisions to conduct regular meetings especially discussing the key issues related to Health and Nutrition and service provisions of ICDS on Health in presence of service providers-AWW and HW(F)s.
- Quality Annaprassana are regularly held with the utilization of village Health Funds in 194 Anganwadi Centres. Out of 301 AWCS of 2 Blocks has a comprehensive understanding/clarity about the importance for quality Complementary Feeding at community level with technical inputs provided by P roject personnel.
- 203 AWCs prepared due lists for timely immunization coverage and reduced the dropout rates out of 301 AWCs. 208 AWCs are regularly maintaining a continuous effort which seems that they have realized the importance of preparing it through constant motivation of PC/APCs.
- ✓ 20% reduction in migration

Environment

Environmental protection is a practice of protecting the environment, on individual, organizational or governmental level, for the benefit of the natural environment and (or) humans. Due to the pressures of population and our technology the **biophysical environment** is being degraded, sometimes permanently. This has been recognized and governments began placing restraints on activities that caused **environmental degradation**. Since the 1960s **activism** by the **environmental movement** has created awareness of the various **environmental issues**. Protection of the environment is needed from various human activities. **Waste, pollution**, loss of **biodiversity**, introduction of **invasive species**, release of **genetically modified organisms** and toxics are some of the issues relating to environmental protection.

WORD: DISTRICT RESOURCE CENTRE (DRC) of NAWO



WORD is working as the district resource centre of NAWO, Orissa chapter since 2006. It has been carrying out different activities and programmes on behalf of NAWO at the grass root level with the financial, human resource and other support from NAWO, Orissa. The details of the activities carried out in the last year are detailed below:

Strengthening Panchayati Raj System



SIRD and Self Governance system are two separate projects for strengthening Panchayati Raj system. Self Governance system project is supported by CWS, Secunderabad for the capacity Building of PRI Members to strengthen the Panchayati Raj Institution. Besides that, WORD has done partnership with SIRD, Orissa to strengthen the Panchayati Raj Institution through capacity building of PRI members.



The Objectives of PRI Training:

- ✓ To build up the capacities of the women PRI members
- ✓ To build and develop skill among women PRI
- To develop their knowledge on PRI system and deliver effective service as a peoples representatives.
- To increase their knowledge on Panchtyat budget and enable women PRI to take active part in panchayat budget preparation
- ✓ To prepare women PRI for next election
- ✓ To build up capacities of women PRI on different issues
- ✓ To disseminate information to women's groups in the regions on women related matters – government policies, schemes etc
- ✓ Over all to make the women PRI active in the governance system.

Training is also given to them on the role and responsibility, transparency and accountability, social audit etc.

Impact of the Training:

- ✓ They are attending the panchyat meetings regularly
- Their participation in palli sava increased women PRI are now involved in Micro plan preparation
- ✓ Women PRI are exposed to different programmes
- They are taking part in implementation of NREGS and other antipoverty programmes and forest right programmes.
- ✓ Women PRI are taking lead in violence cases against women
- ✓ Taking active part in beneficiary selection
- ✓ They could know and take active part for implementation of Social security programme
