- Women Empowerment
- Natural Resource Management
- Education
- Health & Nutrition
- Self Governance System
- Lobby and Advocacy, livelihood development of marginalized section

In the year 1990 WORD got birth and latter on associated with likeminded social activist, tribal service promoter and organization of same line. With an aim of extending its service scopes touching to the every corner of the tribal section WORD was registered under the society registration Act 1860 in the year 1992. In course of time it got support from various agencies both from within and outside the State which has helped it to march ahead. At present WORD is working in Keonjhar District. WORD is not only working within the periphery of Keonjhar but it has widely spread its horizon beyond the district like to Deogarh District.

The head office of WORD is located at Khajuria of Akul of Keonjhar district. WORD has five field offices which are located in five different places: which are Telkoi at Khuntapada, Banspal at Hatapada, Joda of Keonjhar and in Deogarh at Dudhianali and proper Deogarh town.

Forest based livelihood Programme (FBLP):

Forest is vital livelihoods support for mankind especially for the tribal and the rural poor those who heavily rely on forest for food, faggot, medicines and NTFP.

Objective of the Project:

Strengthening multi stake-holder collaborations in people's forestry and improving the livelihood of tribal through strengthening the VSS and preservation, conservation and utilization of forest resources

Area of operation:

15 villages of Bayakumutia GP of Keonjhar BJP range, Khuntapada and Deulidhia GPs of Telkoi Range of Keonjhar district.

Implementation procedure:

Organizing the VSS member capacitated them and mobilizing the Govt department for the development of livelihood options for the community.

Since the inception of WORD, 1992 it has been working in the field of education aiming to educate and to increase the literacy percentage and above all to make them fit to lead a manageable life through life skill education. Since those days till now it has incorporated various educational projects in its educational activities scenario like TLC, PLC, EFA and since 2006 Aug to date it has been working on **SIKSHA CHETANA** with the support of Development Focus and Educan Foundation, NCLP by DLO, 2nos of NRBCS. To the field of vocational education, tailoring, tamarind processing unit, beekeeping unit in the school and it has also promoted goat rearing.

Health:

Health is a major concern of both individual and the state manhood. It is said health is

wealth and a better society is expected from a good health system .In India, comparison to other developing countries of the world the IMR&MMR is still in a state of pensive .Especially in the tribal pocket of the backward state and district people suffer a lot due to ignorant and unreached health system as a result mother s are at high risk during and after delivery.



The new born are subjected to be affected with various infectious diseases because of in hygienic condition and lack of home based baby care system. Dreaming for the better society means ensuring mothers and children health at first, because children are the future of the country. So ensuring their healthy growth and development ought to be the prime concern of every society.

WORD works in the health sector particularly on issue related to maternal and child health. It also works with the support of OSACS with people affected in HIV/AIDS at Joda block to reduce high risk behavior. WORD is of the view that in order to improve the maternal and newborn health by reducing mortality and morbidity relate to pregnancy and child birth .It is essential to build a range of care that increases access to and use of skill care during pregnancy, birth and postpartum period .

WORD with the support of innovation and in association with CONCERN worldwide is working in Maternal and New Born child Health with the introduction of (MNCH-MHA) project, total 83nosof Male Health Activist in 83nos of villages in2nos of Blocks named Banspal and Telkoi of Keonjhar District are facilitating this service with ASHAs being associated with ANM,AWW and ICDS. This project is mainly concerned with the mother and child health care. The major objective of the project is provision for health services to the remote packages covering the PTG, ST, SC and other backward community through male health activists to achieve the ultimate result of reducing IMR and MMR.

Major Activities & Achievements on Health Sector:

FRA

Forest Right Act -06 is a concept relating to the tribal right over forest land as it is strongly associated with their lives and livelihoods. But since the independence it was under the Govt jurisdiction in the purview of forest and environment Deptt. But taking the above facts in to consideration the Govt of India decided to give some rights to adjacent tribal people over the forest land for the preservation and utilization for their livelihoods .So in the year 2006 the Govt of India with the consultation of forest and environment Deptt and Tribal welfare Deptt passed an act namely FRA-06. With these benevolent steps of the Govt tribal got an opportunity to use the forest land for their livelihood purposes. During the reporting period total 8153nos of application had been filed under FRA-06. Out of those application 2695 nos individual got land entitlements. 3nos of community clams have been finalized and 148 women headed family have got land entitlements. Rest **3550** nos of claim forms are under processing, as the Govt procedure follows the principle of redtapism. However, the applications on community claims have not been verified yet, let alone considered and disposed of. The Project functionaries are nevertheless carrying forward their lobbying exercise with the concerning Govt. authorities for early disposal of community claims.

NREGS Facilitation

The MGNREGA which is in a state of crux all over the state and Keonjhar district is not free out of that situation. Here also people are being deprived of getting the opportunity in a proper way. But in course, tribal people were sensitized and demanded job for their sustenance. 1744nos of job card holders had applied for jobs and out of this number1698 only nos of job card holders got job creating an average 60 nos of man days. As a result a number of durable assets were created like firm ponds, Balibandhas, Village ponds reclamation, road connectivity and many more for the sustenance of their life.

District Resource center (DRC) of NAWO:

WORD is working as the District Resource Center of NAWO, Odisha chapter since 2006. It has been carrying out different activities and programmes on behalf of NAWO at grass root level with the all round hand holding supports for violence against women of NAWO, Odisha.

Case study:

A BAMBO IS A RAY OF HOPE

Jagat Dehury, age 30 a physically challenged person of Mundula Village in Bayakumutia GP under Banspal Block. His family is consisting of two members he and his mother, Sumati Dehury, widow 52 years.

He is a poor and marginal farmer having only 50 decimals of land holding. He was being humiliated by the villagers due to his poverish and physically challenged condition. Two meals in a day for his family was a question mark. But with the intervention of lead Organization of Keonjhar District WORD and its SRI method, Jaga got a means to live. He understood the system and benefit from the SRI system and made up his mind to adopt it in his cultivation.

Jaga applied the system in his field but the major problem faced in the cultivation, is the scarcity of water due to draught situation. Taking to the water crisis situation Jaga did not become broken hearted. He thought of a plan how to save his green field. Ultimately he found out a solution and that is the use of the stream water which is flowing near the fields. But how could he use the flowing water, as he is poor and he has no capacity to hire a pump set to draw water from the stream. But as the necessity is the mother of invention.

Jaga thought of a plan and implemented it through a long 18 feet bamboo pipe. He used his innovative idea, cleans the knots by making holes in the Bamboo and catches the flowing water at the dropping head and channelized the water and solved the irrigating problem in his SRI cultivation field. Now his field is in growing stage with the full of green hills bearing 45nos tillers.

Nobody could not but commend to his innovative idea. Now he is proud of his innovative invention
